

## Tim's Turkey Contest

**Official Rules:** Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Tim's Turkey Contest ("Contest") will begin at 12:01 AM Eastern Standard Time (EST) on March 17, 2010 ("Contest Start Date"), and end at 11:59 PM Eastern Daylight Time (EDT) on June 1, 2010 ("Contest Period"). Contest is sponsored by the THEODORE ROOSEVELT CONSERVATION PARTNERSHIP, INC., a non-profit corporation established in the District of Columbia ("Sponsor") located at 555 Eleventh Street NW, 6th Floor, Washington, DC 20004.

**Eligibility:** Contest is open to all active Unions Sportsmen's Alliance members with a valid membership id number who harvest a turkey legally on North America during the 2010 spring turkey season and submit an entry form between the contest start date of March 17, 2010 and end date of June 1, 2010. All entrants must be 18 years of age or older as of "Contest Start Date" in order to win the grand prize of a Beretta American Citizen shotgun. **Winner must be an active or retired member of an AFL-CIO affiliated union or a direct family member of an active or retired AFL-CIO affiliated union member.** Employees, officers and directors of the Sponsor, their affiliates, subsidiaries, agents, and vendors (collectively including Sponsor, "Contest Entities") their immediate family members (parents, children, siblings, spouses) and persons living in the same household (whether related or not), are not eligible to participate in the Contest.
