



Union Sportsmen's Alliance "Build the USA" Sweepstakes

Official Rules: Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Union Sportsmen's Alliance Build the USA Sweepstakes ("Sweepstakes") will begin at 12:01 AM Eastern Standard Time (EST) on February 26, 2010 ("Sweepstakes Start Date"), and end at 11:59 PM Eastern Daylight Time (EDT) on May 31, 2010 ("Sweepstakes Period"). Sweepstakes is sponsored by the THEODORE ROOSEVELT CONSERVATION PARTNERSHIP, INC., a non-profit corporation established in the District of Columbia ("Sponsor") located at 555 Eleventh Street NW, 6th Floor, Washington, DC 20004.

Eligibility: Sweepstakes is open to all active Unions Sportsmen's Alliance members with a valid membership id number who join the USA, renew their membership in the USA or refer a friend who joins the USA between the sweepstakes start date of February 22, 2010 and end date of May 31, 2010. All entrants must be 18 years of age or older as of "Sweepstakes Start Date" in order to win the grand prize of a Beretta American Citizen shotgun. **Winner must be an active or retired member of an AFL-CIO affiliated union or a direct family member of an active or retired AFL-CIO affiliated union member.** Employees, officers and directors of the Sponsor, their affiliates, subsidiaries, agents, and vendors (collectively including Sponsor, "Sweepstakes Entities") their immediate family members (parents, children, siblings, spouses) and persons living in the same household (whether related or not), are not eligible to participate in the Sweepstakes. How To Enter: Members of AFL-CIO affiliated unions and their family members will be entered automatically into the drawing if they join the USA, renew their membership in the USA or refer a friend who joins the USA between the sweepstakes start and end dates. By participating, you consent for Sponsor to obtain, use, and transfer your name, address and other information for the sole purpose of administering this Sweepstakes. Sweepstakes Entities are not responsible for: lost, late, incomplete, illegible, incorrect, delayed, garbled, undelivered, misdirected, stolen, postage-due registrations, entries or mail.

Prizes: **One (1) Grand Prize** winner will receive a (1) Beretta 3901 American Citizen Synthetic 12-gauge shotgun. The Approximate Retail Value of the Grand Prize is \$900. Winner must be 18 years or older and able to pass a federal background check at the time of the drawing. If, for any reason, the winner does not pass the federal background check, the gun will be donated back to the Union Sportsmen's Alliance and another winner will be drawn. The firearm cannot be transferred to a friend or relative in winner's stead. **One (1) First Prize** winner will receive a (1) Full Force Griz bow. The Approximate Retail Value of the Grand Prize is \$800. **One (1) Second Prize** winner will receive an (1) Ardent XS1000 Baitcasting Reel. The Approximate Retail Value of the Grand Prize is \$270. **Twenty-five (25) Third Prize** winners will receive a (1) Fern Creek 1 ½" Shad Spoon lure. The Approximate Retail Value of the Grand Prize is \$3.50. By accepting the prize, prize winner agrees to release Sweepstakes Entities from any and all liability whatsoever for any injuries, losses, or damages of any kind caused by entering the promotion or for damages of any kind caused by any prize or resulting from acceptance, possession, or use/misuse of prize awarded.
